Disclaimer and Waiver of Liability

I hereby acknowledge that I have voluntarily applied to participate in dog training activities with Contact Sports Agility (CSA). I am aware that there are inherent risks and hazards involved with and around dogs, and I am voluntarily participating in the activities with the knowledge of these potential dangers. I am not relying on CSA OR DIANE AND LES SANDERS to prevent such occurrences. In order to participate in CSA training classes, demonstrations, or other activities, I, being fully informed of such risks and hazards, agree to assume ALL RISK OF SUCH OCCURRENCE.

I hereby waive any and all claims or actions I or my guardians, representative or assigns may have against CSA OR DIANE AND LES SANDERS and agree to release CSA OR DIANE AND LES SANDERS from liability in any and all personal injuries to myself, my dog, children in my charge, or harm to property causes directly or indirectly by any acts that might occur in conjunction with dog training classes, or other activities. I also agree to assume sole responsibility for injury or damage caused by myself, children in my charge, or by the dog I own or handle during participation in CSA classes, events and activities and further indemnify, defend, and hold CSA OR DIANE AND LES SANDERS harmless from any damage, loss, liability, or expense, including legal costs and attorney fees, which result from damage caused by myself, children in my charge, or the dog I own or handle.

RELEASE OF LIABILITY -- I have carefully read this release of liability and fully understand the contents thereof. I am aware that this is a release of liability and a contract between CSA, and me and I agree to it of my own free will.

Bitches in Season

Bitches in season are allowed to work at Camp but *need to wear britches at all times*. You may be asked to potty your dog in a special location and crate away from the other dogs during each session. Please inform CSA if your dog comes into season or is expected to come into season during camp.

Cancellation Policy

As much as we care about all of our customers and their dogs, and we are extremely pained when we hear of either personal or canine tragedies, camp is a business. We cannot keep running camp if costs are greater than income and labor expended. We budget and hire instructors for camp based on being able to fill an exact number of spots. The instructors and the facility don't care how many people ultimately attend camp – they charge us the same amount of money no matter what. We had to develop a cancellation policy that takes this into consideration and that treats everyone equally. We do not make exceptions to this policy as it is impossible to judge whether one person's emergency is more important and more deserving of a refund or credit than the next person's. We do the best we can to maintain an active waiting list, but we cannot guarantee that there will be a waiting list if you have to cancel.

It is critical that you read the following information carefully as there are NO exceptions to our cancellation policy other than being called to active military duty.

- Your initial deposit – Half the cost of the seminar is **NON-REFUNDABLE/NON-TRANSFERABLE**. Any camp cancellation, regardless of reason, forfeits that deposit.
- If you cancel your camp reservation June 1, 2010 or after, 50% of the total fees paid will be refunded **ONLY IF YOUR SPOT CAN BE FILLED** with an eligible participant.
- It is highly unlikely that we will be able to fill cancellations during the month prior to camp as it's too late for people to make plans. If we cannot fill your spot, you will forfeit 100% of the total camp fees paid.

CANCELLATION POLICY -- I have read the above cancellation policy and I agree to all terms. I understand that there are NO EXCEPTIONS to the policy regardless of the reason that I cancel my Camp reservation. I understand that cancellation after June 1st may result in my receiving NO REFUND if my spot in Camp cannot be filled from the waiting list. I also understand that I may not give nor sell my spot in camp to another person unless I am an auditor.
